A NOTE FROM **KATIE PORTER**

Dear neighbor.

As a single mom of three living in Irvine, I understand the sticker shock that Orange County families have been feeling at the grocery store and the gas pump. That's why I'm fighting to hold large corporations accountable for price gouging consumers to line the pockets of their CEOs and shareholders.

I'm a proud capitalist, and what we're seeing here is a broken market. While Americans struggle to afford basic necessities, corporate profit margins are the highest they've been in more than 70 years. Wall Street is using supply chain disruptions caused by the pandemic and Russia's invasion of Ukraine as a cover to exploit families.

Healthy capitalist markets-especially those involving essential goods like food and fuel-depend on competition. Without it, prices go up. Huge international corporations get away with price gouging because they have driven competitors, including small businesses, out of the market-and because too many in Washington lack the courage to stand up to corporate abuse. I'm willing to do so, always putting Orange County families first.

I'm committed to standing up to Big Oil, Big Ag, Big Pharma, and Big Insurance to lower costs for Orange County families.

I'm proud the House passed my bill to crack down on the oil industry's excessive price hikes. I recently voted for legislation to help bring down meat prices and make insulin affordable. I'm continuing to push for bills that tackle market consolidation and boost antitrust enforcement, which will stabilize our economy long-term.

BILL SPOTLIGHT: Rep. Porter's Consumer Fuel Price Gouging Prevention Act Cleared the House

Big Oil is threatening our entire economy by keeping fuel supply low and hiking prices far beyond their input costs to satisfy Wall Street. A recent survey conducted by the U.S. Federal Reserve found that **60% of oil** executives believe "investor pressure" to maintain record profits is the main driver of high gas prices. Just 6% cited government regulations.¹

So far, Big Oil's scheme is working: profits are at a 7-year-high and corporations are planning \$40 billion in stock buybacks to enrich shareholders.

Rep. Porter knows gas prices are squeezing families. She introduced the Consumer Fuel Price Gouging Prevention Act to hold Big Oil accountable for keeping supply low and prices high. The House passed her legislation in May.

Rep. Porter Is Spearheading Legislation to Lower Costs for Orange County Families

Giant corporations backed by Wall Street are using inflation as a smokescreen to hike prices and rake in their fattest profit margins in 70 years. Rep. Porter is championing several bills to crack down on this price gouging, enforce antitrust laws, promote competition, and lower prices at the grocery store and gas pump.

✓ The bipartisan Lower Food and Fuel Costs Act would cut costs for farmers, invest in biofuels, and crack down on anti-competitive behavior in the meatpacking industry. Rep. Porter joined Democrats and Republicans to pass this legislation to lower costs for families and strengthen food supply chains.

The bipartisan Meat Packing Special Investigator Act would make it easier for the U.S. Department of Agriculture to investigate potential violations of antitrust laws in the meatpacking industry. Rep. Porter joined House Democrats and Republicans to approve this legislation in the House.

✓ The Big Oil Windfall Profits Tax Act would clamp down on polluters that price gouge and return the revenue to families through a rebate.

✓ The **Price Gouging Prevention Act** would allow the Federal Trade Commission and state attorneys general to enforce a federal ban against corporations that unfairly hike prices.
