



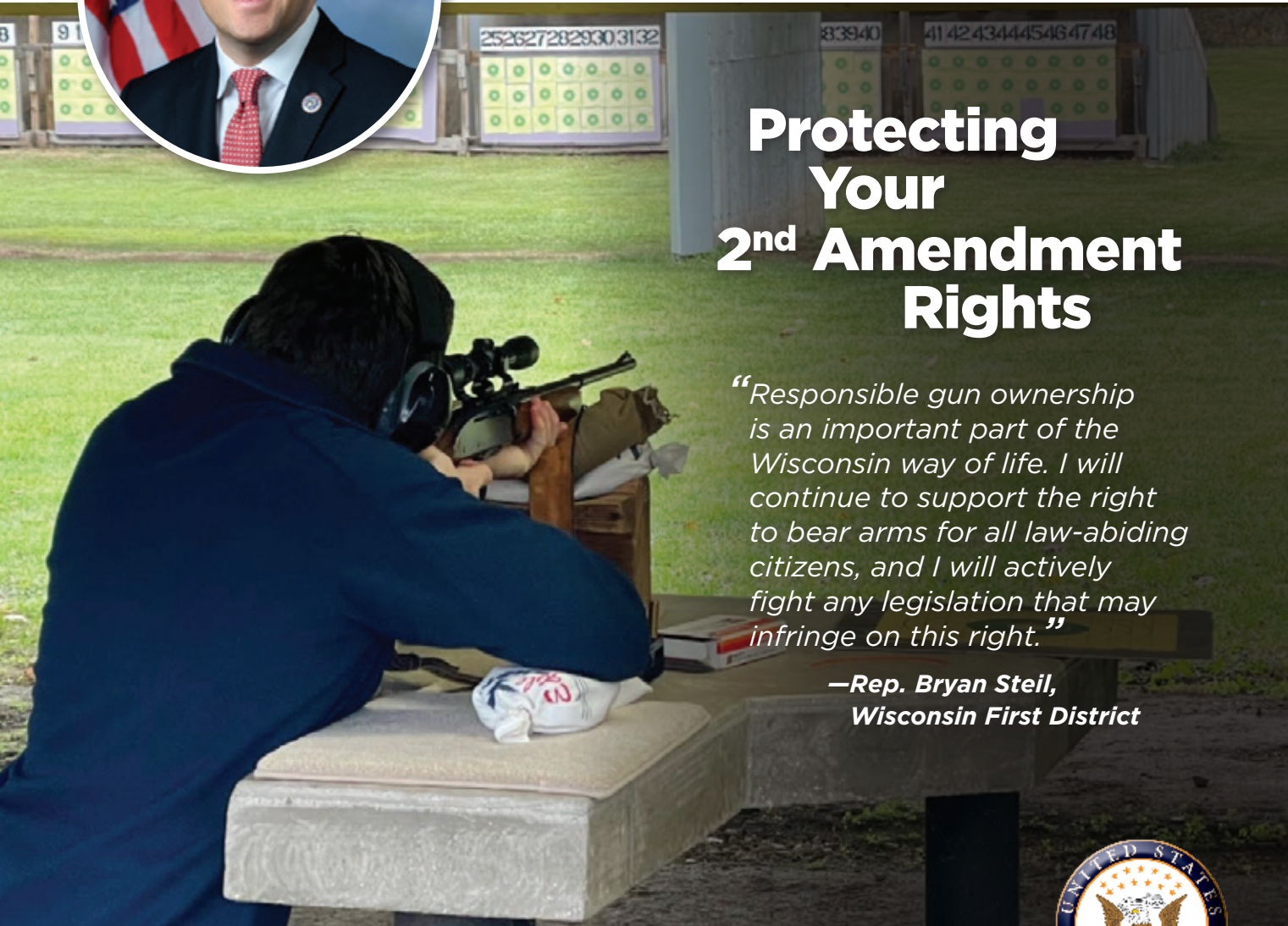

Protecting the Rights of Law-Abiding Gun Owners

PROTECTING OUR RIGHTS

The American Founders provided the Second Amendment so that all Americans could have an effective way to defend themselves and their families. To protect this Constitutional right, Rep. Steil voted against H.R. 8, a bill to expand the power of the Attorney General and further restrict firearm access.

ADVANCING THE 2ND AMENDMENT

To advance our 2nd Amendment rights, Rep. Steil was an original co-sponsor of the Concealed Carry Reciprocity Act (H.R. 38), which allows individuals who have a concealed carry permit in one state to legally carry in all states with similar concealed carry permissions. Moreover, Rep. Steil co-sponsored the Protecting the Right to Keep and Bear Arms Act (H.R. 1534) to prevent the Department of Health and Human Services (HHS) from using emergency or disaster situations to restrict gun rights.
