## DELIVERING FOR IOWA FAMILIES

### Securing Our Border

**Led legislation**, which passed the House, condemning the use of elementary and secondary schools to provide shelter for illegal aliens. **Voted in support of H.R. 2**, the strongest border security bill that has passed the House.

### Stopping Government Overreach

**Authored an amendment** to prohibit federal funding of gun control research at the CDC, which passed the House. **Introduced the "Lead by Example Act"** to require that the Department of Energy follow their own recommendation and set their thermostats to 78 degrees, as they expect Americans to do. **Demanded that we protect U.S. sovereignty**, instead of ceding to WHO, while working collaboratively to address international public health policies preventing and responding to potential pandemics.

### Supporting Our Seniors

**Led the way to require greater transparency in pharmaceutical pricing (H.R. 2816)**. And worked to guarantee that medical equipment suppliers can provide their products at an affordable rate. **Introduced the "Share the Savings with Seniors Act"** which lowers out-of-pocket costs for our seniors with chronic medical conditions.

### Advocating for High Quality Healthcare

**Introduced H.R. 6283 to ban unfair practices that are driving up prescription drug prices and forcing people to pay more than they should.** My bill, the PREEMIE Act, passed the House reauthorizing critical research, education, and intervention activities to reduce preterm birth and infant mortality. Advocated for legislation **(H.R. 4779)** to ensure that breast cancer patients and survivors who have had a mastectomy are able to access custom breast prosthetics under Medicare.

### Fighting for Rural Communities

**Worked to ensure that more goods are manufactured in the United States**, and advocated that products that are key to our critical infrastructure sectors are produced in our rural communities. **Introduced legislation to expand rural broadband investment and deployment in rural areas.**

### Honoring our Flag

**Sponsored legislation to ensure** that the only flags flown on federal property are the United States flag, state flags, tribal flags, and Armed Forces POW/MIA flags.

### Affordable, Clean Energy

**Introduced legislation to require the EPA to include solutions**, like flex fuel vehicles, as a low-carbon alternative option to electric vehicles. Serve on the Energy and Commerce Committee to fight for lower energy prices and the option of E-15 year-round. Holding firm during debt limit negotiations for renewable energy credits which help our farmers with conservation practices. **Worked to pass legislation** in the House to prohibit the implementation of the Biden Administration's egregious EV mandates.

### Fighting for Farmers

**Working to safeguard** commodity and conservation programs, agriculture production, and crop insurance initiatives in the Farm Bill.

### Keeping Our Promises to Veterans

**Fought to pass legislation to make the VA healthcare system more accessible and accountable** to those in need. Proudly led discussions with colleagues and experts on **improving veteran mental health** and combating veteran suicide.
